- c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
- d. "including" is understood to mean "including without limitation";
- e. Reference to any statutory provision includes and modification or amendment of it;
- f. The headings and subheadings do not form part of this privacy policy.

### **Scope of this privacy policy**

3. This privacy policy applies only to the actions of Ethos Vision and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
4. For purposes of the applicable Data Protection Laws, Ethos Vision is the “data controller”. This means that Ethos Vision determines the purposes for which, and the manner in which, your Data is processed.

### **Data collected**

5. We may collect the following Data, which includes personal Data, from you:
  - a. Name;
  - b. Gender;
  - c. Contact information such as email addresses and telephone numbers;In each case, in accordance with this privacy policy.

### **How we collect Data**

6. We collect Data in the following ways:
  - a. data is given to us by you; and
  - b. data is collected automatically.

### **Data that is given to us by you**

7. Ethos Vision will collect your Data in a number of ways, for example:
  - a. when you contact us through the Website, by telephone, post, e-mail or through any other means;
  - b. when you register with us and set up an account to receive our products/services;
  - c. when you make payments to us, through the Website or otherwise;
  - d. when you use our services;

in each case, in accordance with this privacy policy.

### **Data that is collected automatically**

8. To the extent that you access the Website, we will collect your Data automatically, for example:
  - a. we automatically collect some information about your visit to the Website. This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.
  - b. We will collect your Data automatically via cookies, in line with the cookie settings on your browser. For more information about cookies, and how we use them on the Website, see the section below, headed “Cookies”.

### **Our use of Data**

9. Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience when using our Website. Specifically, Data may be used by us for the following reasons:
  - a. Internal record keeping;In each case, in accordance with this service policy.
10. We may use your Data for the above purposes if we deem it necessary to do so for our legitimate interests, If you are not satisfied with this, you have the right to object in certain circumstances (see the section headed “Your rights” below).
11. When you register with us and set up an account to receive our services, the legal basis for this processing is the performance of a contract between you and us and/or taking steps, at your request, to enter into such a contract.

## Who we share Data with

12. We may share your Data with the following groups of people for the following reasons:
  - a. Our employees, agents and/or professional advisors – to process payments and send out orders of product purchased by the customer;In each case, in accordance with this privacy policy.

## Keeping Data secure

13. We will use technical and organisational measures to safeguard your Data, for example:
  - a. access to your account is controlled by a password and a username that is unique to you.
  - b. We store your Data on secure servers.

## Data retention

## Your rights

18. You have the following rights in relation to your Data:
  - a. Right to access – the right to request (i) copies of the information we hold about you at any time, or (ii) that we modify, update or delete such information. If we provide you with access to the information we hold about you, we will not charge you for this, unless you request “manifestly unfounded or excessive.” Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.
  - b. Right to correct – the right to have your Data rectified if it is inaccurate or incomplete.
  - c. Right to erase – the right to request that we delete or remove your Data from our systems.
  - d. Right to restrict our use of your Data – the right to “block” us from using your Data or limit the way in which we can use it.
  - e. Right to Data portability – the right to request that we move, copy or transfer your Data.
  - f. Right to object – the right to object to our use of your Data including where we use it for our legitimate interests.
